

For this reason, Francis believes that we do not need to repeat our call for extra desserts next week. If the situation changes for the worse, however, we will let you know. are no longer needed, willing volunteers are always welcome to help on Tuesday mornings (when FPC members are at Christ's Kitchen in force) or on any weekday morning when you can help.

Please remember, also, we are now posting not only our Newsletters but also videos of our worship service on the FPC website (www.fpcofvicoria.org). It takes only a day or so for the Newsletter to be posted on the website (go to our home page, click on "News & Events," and then, from the "drop-down menu," click on Newsletters. Click on the month you are interested in, and the link for the specific Newsletter you are looking for will appear.

It takes a little more time (4 to 5 days) for a video that appears on our Facebook page to be transferred over to our website, but we will continue to make those transfers in an effort to reach a larger audience inside and outside the Victoria community. SESSION WILL MEET BY VIDEO CONFERENCE
ON TUESDAY, MAY 12, 2020,
TO CONSIDER "GOING FORWARD" PLANS:
YOUR INPUT IS REQUESTED

The FPC Session will meet on Tuesday evening, May 12, 2020, by video conference to consider important issues facing the church in these trying times. As usual, we will revenue the financial statements of the church through the first four months of this year. After guiding the spiritual affairs of the church, the Session considers its duty of stewardship to be among its most important responsibilities.

Jim Stokes, our Treasurer and a currently serving Ruling Elder, informs me that so many faithful members of our congregation have found ways to keep their tithes and offerings current even though we are no longer able to "pass the plate" during our worship services. To all of you, the Session expresses its heartfelt thanks for your faithful, loving, and timely giving to support the church we all love so much. At the same time, our revenues are, not unexpectedly but not yet alarmingly, down from the levels we had budgeted as if we would have been meeting continuously in the Sanctuary on Sunday mornings.

We understand, also, that some of our members may be facing their own financial hardships in this time of a greatly weakened economy. To such friends, I invite you to contact the Chair of our Caregiving & Fellowship Committee, Gayla Whitaker, or me to express in confidence any cares, concerns, or hardships you are facing. Perhaps the church can help. Meanwhile, we encourage you to take care of your personal financial needs first and foremost.

At the same, if anyone notices that they have perhaps inadvertently delayed their planned periodic contributions to First Presbyterian Church, we would be grateful if you would carefully and prayerfully consider mailing, or dropping off, your contribution at the Church Office. We are doing our best to reduce our expenses (in utilities, office supplies, the use of contractors, and any other way we can think of). If we carefully manage our funds, we should, with your support, be able to resume public worship at full strength when the time is right.

The Session will also be considering the pivotal question of *when* to resume public worship at FPC. On this subject we shall be led by the Holy Spirit and by the recommendations and data provided by those whom God has gifted with the blessings of medical expertise. For your Session this is not a political issue, it is a public health issue.

As we consider how to proceed, we would very much appreciate input (via letter or email) before our meeting from interested members of our congregation. For example, do you believe we should reopen worship in the Sanctuary "as soon as possible?" Do you believe that the first Sunday in June (June 7, 2020) might be a

reasonable time? Do you believe that we should continue to wait until more testing becomes available or until some other public health benchmark is reached (e.g., a sustained decline in coronavirus infections in our area)? Would your answers be different if the Session could find the financial resources to continue broadcasting our worship services over social media (be aware, however, that "live broadcasting" is a much more complicated and expensive proposition than "pre-recording" our worship services as we now do)?

Naturally, at the end of the day, even if we reopen the Sanctuary, we will do so subject to appropriate social-distancing protocols. Moreover, we would not want anyone to attend who was not yet comfortable being present at social gatherings, even when such protocols are followed. First and foremost, we want to protect the precious lives that God has given us. That is the primary imperative by which we want our members to be led. Whenever we return to the Sanctuary, it will be, as always, to thank God for his many blessings and to pray that he guard, protect, and maintain the safety of all his children whether they are present in the Sanctuary or not.
