FPC SESSION UPDATES OUR CHURCH'S COVID-19 PANDEMIC GUIDELINES

Since the inception of the COVID-19 pandemic, the Session has been carefully monitoring CDC guidelines regarding the safety of indoor gatherings, particularly the gathering of our members and visitors for in-person worship in our Sanctuary.

Sensing there might be a loosening of the guidelines as a result of the large number of wise individuals across the country who have obtained their full round of vaccinations, some six weeks ago the Worship Committee of the Session appointed a small group to consider when, in fact, it might be safe to resume public singing in our Sanctuary. As always, however, the members of the Worship Committee, as well as the entire Session, have insisted that our decisions be guided by science and reliable data.

With the recent announcement by the CDC that *fully vaccinated individuals* could resume participating in public activities without wearing a mask or physically distancing, except where required by federal, state, or local laws (https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html), the Session determined that it was appropriate to update FPC's COVID-19 Guidelines.

A copy of these updated guidelines appears at the end of this Newsletter.

Revised pamphlets containing these guidelines will be available at the entrances to the church this Sunday. Please read the guidelines carefully. Essentially, the Session has determined that the wearing of facemasks during our worship services will be optional *for those who have been fully vaccinated for at least two weeks*. Also, those who sit in the front half of the Sanctuary will be welcome to sing our hymns aloud.

The Session has asked me to be very clear in the following regard. If, *for any reason whatsoever*, a member prefers to continue wearing a facemask while at church, their preference will be respected. We fully understand the desire to be super-cautious. Moreover, those preferring not to sing or to be among those who do, are welcome to sit in the back half of the Sanctuary.

In making this common-sense accommodation, the Session does not want to appear to be endorsing separation or segregation— such concepts are antithetical to all that Presbyterians believe about the inclusiveness of all God's people in our midst. *For the time-being*, however, this is one of those practices that appears to be wise and appropriate in the present circumstances.

I shall not repeat other details in the updated guidelines regarding such matters as the taking of the offering, the celebration of the liturgy, and like matters. Instead, I again encourage you to carefully read about those details in the Appendix that appears at the end of this Newsletter.

As God leads us out of the scourge of this pandemic, let us be ever mindful of those who have suffered greatly (including the loss of loved ones), not only in our nation but around the world. Let us ask God to grant his tender mercy and steadfast comfort to those who mourn, to those who continue to suffer, and to those who seek to rebuild their lives after this terrible time of hardship and tragedy.


Let us also remember not to let our guard down as things begin to return to a "post-COVID normal." Let us remain careful and cautious out there as we return to a life of community.

JOIN FELLOW FPC MEMBERS IN SERVICE TO THE HOMELESS AT CHRIST'S KITCHEN

In keeping with a long-standing commitment of service to others, several members of First Presbyterian Church, Victoria meet weekly to help prepare for the Tuesday meals served at Christ's Kitchen. Volunteers from First Presbyterian begin chopping fruit and vegetables for salads as well as cutting and boxing desserts on Monday afternoon between the hours of 1:30 - 4:30 pm. The remainder of our portion of the meal preparation is completed on Tuesday morning beginning at 7:00 a.m. Currently, enough food is being prepared to serve between 500-600 to-go meals. During this time, the safe practice of wearing masks is still observed, and no one (other than volunteers) is allowed inside the building.

If you would like to help by joining in during this food preparation, just come to Christ's Kitchen any time on Monday afternoon between 1:30 and 4:30 pm. Extra hands, in service to the less fortunate among us, are always welcome!

Several members have asked that we reprint the information from last week's Newsletter concerning the serious illness of one of the granddaughters of FPC's good friends, the Rev. and Mrs. Fred Hobbs. The eight-year girl, Keimryn Lee, is the daughter of Askaskia Hobbs, whom many of us know through her work at her father's church, Mt. Nebo Missionary Baptist Church.

Keimryn Lee is being treated for pediatric cancer in the Houston Medical Center. We shall pray for the welfare and prompt healing of this dear child. APPENDIX TO NEWSLETTER: UPDATED COVID-19 PANDEMIC PUBLIC HEATH AND SAFETY PROTOCOLS FOR IN-PERSON GATHERINGS AT FIRST PRESBYTERIAN CHURCH OF VICTORIA, TEXAS

As We Enter

- · Facemasks must be worn *at all times* by those who have not yet been fully vaccinated for at least two weeks.
- · For those who have been fully vaccinated for at least two weeks, facemasks are *optional*. Nevertheless, regardless of their vaccination status, anyone may choose to wear a facemask as they desire. Anyone wearing a facemask will be treated graciously and respectfully.

While We Are Gathered

- · Seating
 - o Certain pews, which will be clearly marked, will be remain closed to seating.

- o Those who do not wear facemasks, and those who wish to sing, should sit in the front half of the Sanctuary.
- o Anyone who is reluctant to be around those who are not wearing masks, or around those who are singing, should sit in the back half of the Sanctuary.

· Worship

- o *Singing*: For vaccinated members, no facemasks will be required, and singing will be allowed in the front half of the Sanctuary. The lyrics to the hymns, (together with the appropriate Scripture lessons) will be printed in the Bulletin to minimize contact with the hymnals and Bibles in the pew racks.
- o *Passing of the Peace*: We will continue to maintain social distancing during the Passing of the Peace. Worshipers will stand in body or spirit and greet one another by waiving and other expressions of love.
- o *Offering*: An offering will be taken by the passing of the collection plates among the congregation. If you do not wish to receive the plate, simply raise your hand slightly to decline receiving it. The passer of the plate will understand and will honor your request. Offering plates will also continue to be placed at the front and back of the Sanctuary for everyone's convenience.
- o *Liturgy*: When indicated in the Bulletin, worshippers will be requested to stand in body or spirit as appropriate for the liturgy.
- o *Communion*: There will be no change to the way we currently serve communion. When served, communion will be voluntary. Those wishing to be served will come forward down the center aisle while maintaining appropriate social distancing. The Elders, wearing clean gloves, will place the host (the bread) into each communicant's cupped hands (please do not reach into the plate to take the bread yourself). The juice will be served in small plastic cups. Each congregant will take his or her own cup. There will be a separate receptacle in which to deposit each cup once it is used (please do not return the cup to the serving dish).

As We Depart

- · You are welcome to linger after a service to the extent you feel comfortable doing so. Please be respectful, however, of those who are trying to leave quickly so as to avoid contact with those who are not wearing masks.
 - · Please tell friends and neighbors who were unable to attend that our worship

services will continue to be streamed on our website (www.fpcofvictoria.com) and on our Facebook page (www.facebook.com/fpcofvictoria). Those who participate via our website will also have the convenience of the appropriate Bulletin being there as well. Please remember, also, that while each service will be streamed live on Sunday morning, it will also be "archived" so that it can be played anytime afterwards.

A Final Note from the Worship Committee

These protocols have been revised in the same manner they were prepared-only after a great amount of research and prayerful deliberation. As before, these protocols remain flexible and subject to change, and thus we welcome input from members and visitors alike about their worship experience while these precautions are in place.

We rejoice that we are able at last to return to a more "normal" worship routine. At church and elsewhere, however, we must not let our guard down. The Coronavirus and its variants are still plentiful among us. Please remain careful and cautious!

When we published our first set of Public Health and Safety Protocols, we knew that many in our midst were still not ready to return to public worship. We understand. The revision of these protocols does not mean that we believe *you* should return to worship. Each of our members should continue to err on the side of caution. If you have even the slightest concern, we encourage you to stay home, join us on our website or on Facebook, and stay isolated until you feel comfortable venturing out. You will not be forgotten or overlooked, for we shall continue to carry everyone in our hearts and prayers. May God be with us all as we continue to cope during these uncertain times.
